The NYSO Leadership Development Committee will host in- person Leadership Development workshops for 2024 - 2026 chapter presidents at the Executive Board meeting and Seminar on April 19-20 at the Delta Hotel in Utica. The sessions will be held for new and returning leaders on Saturday, April 20, 10:30 a.m.-12:30 p.m.

Each Chapter has the responsibility to review and, if necessary, update their Standing Rules EVERY biennium. If your chapter hasn't already started this process then it is time to start. If your chapter decides no changes are needed then all that needs to be done is the addition on the bottom of the last page of the date reviewed by the chapter. Then send a copy to Sue Kenoyer, Karen Crumley and Jennifer Lee-Alden. These are kept in our files as the latest version of your

Standing Rules.

If you decide that changes need to be made then make them, get approval from your chapter and then send them to the same three people mentioned above. Sue Kenoyer will review your Standing Rules. The Committee keeps a file of the latest version of your chapter's Standing Rules. The committee is focusing on Chapter Standing Rules that haven't been sent in since 2020. You will receive a call or an email from a committee member that has been assigned to your chapter. We hope you attend the NYSO DKG Spring Seminar and Executive Board Meeting in Utica.

## **Collegiate Membership**




Are you interested in having collegiate members as a part of your chapter? Alpha Nu is constantly working to grow our membership numbers. Below are some steps we are taking to try to reach out to college students. In keeping with one of the goals of Delta Kappa International, to advance the professional interests of women in education, Alpha-Nu Chapter of New York State provides a \$1,000 Grant-in-Aid Scholarship to a qualifying female high school senior, every May.

The applicant must begin her college studies in the fall semester of that same year in preparation for a teaching career. The selection committee of Alpha Nu recommends that applicants have a strong academic record with a cumulative grade point average of at least 80%. She should be involved in school and community activities. School counselors in Columbia and Greene Counties are given application information and asked to seek out one female senior, who meets these criteria, to apply for the scholarship. The qualifying senior then completes a one-page essay, provides letters of recommendation, and shares their official transcript. The Grant-In-Aid Scholarship committee then carefully reviews the candidates'

applications and one female is chosen. The Scholarship recipient is invited to our May meeting as our guest, along with her family, to receive the scholarship and share her plans for the future. Alpha Nu members look forward each year to this opportunity to meet the chosen recipient and share what Delta Kappa International.

Since this event is always well received within our membership, our current President, Judi Matthews had an idea to celebrate it even more. She reached out to the last 7 recipients of our Grant-In-Aid Scholarship via personal notes inviting them to our May dinner in the hopes we could hear about their progress in college or after if they had graduated. As well as to determine if they went into teaching and maintain contact so we could see if they would like to be a member once they began teaching. Four of them sent back thanks and provided information about their current activities since they were unable to attend due to college classes or exams. Fortunately, one of our more recent recipients attended our last May meeting with her mother and we were able to hear all the amazing things she was up to, including traveling to Korea! It was a nice evening for all.

I hope that we can keep in communication with our recipients and encourage them to join as collegiate members or eventually as teachers. What are ways your chapter can reach out to college students? Or make a connection with seniors as they head off to college?

## Mentoring an In-coming Chapter President

Here is a wonderful article from the International DKGSI Blog Spot to help us remember we need to provide support for our new leadership. This is especially important as our presidents and chapter leaders begin a new biennium. Anna Marie Bonafide, NYSO First VP and LDC Chair



It's the time of year that chapters are selecting new leaders for the next biennium. Unfortunately, this task is harder and harder. Members are reluctant to step into the roles of chapter officers, especially that of president.

What if the in-coming president is assured of assistance in the form of a mentor? With a mentor to provide guidance, reluctance may take a back seat.

The logical mentor may be the immediate past chapter president, but that does not always have to be the case. Any of the past chapter presidents can fill that role. Past chapter presidents have experience and insights necessary to share with the new president.

With prior planning, the chapter can ensure that this transition is smooth and less stressful. An arrangement can already be in place that guarantees mentorship of a new chapter president. Many resources are available for chapter presidents, and those can be daunting at first glance. A mentor can take the time to study those with an in-coming chapter president and offer advice. Among those resources are the International Constitution and International Standing Rules, The Handbook of The DKG Society International, and a Leadership Calendar, all of which are found on the DKG website. Additionally, chapter rules need to be examined.

The relationship between the mentor and in-coming chapter president needs to be on-going and intentional. For success to occur, time needs to be allocated and devoted to the needs identified through each meeting. These meetings can occur in a variety of settings and manners. Face-to-face, while often the most desired, can also occur via a virtual platform such as Zoom, Facetime or Google Meet. Scheduled check-ins could include emails, texts, or phone calls. The chapter president should also feel comfortable contacting her mentor at any time with questions. The importance of working as a team is fostered with the mentor and in-coming chapter president relationship. The incoming leadership team can also be included in some of the beginning meetings that set the stage for the new biennium.

As a mentor, past chapter presidents provide the following skills to an in-coming chapter president and her leadership team.

- Exhibit characteristics of a positive role model.
- Provide guidance as well as constructive feedback.
- Build mutual respect and trust.
- Share skills, knowledge, and expertise.
- Demonstrate commitment.

In turn, the in-coming leadership team can develop and expand their leadership skills for their own benefit and that of their chapter.

Now is the time to look at your chapter and what is in place to nurture and support your in-coming chapter leaders, and most especially your chapter president. If you do not have a mentor program in place, consider developing a plan now. This may be the answer to the reluctance of members to take on leadership roles. Soon we will be offering congratulations to our new chapter officers. Success is only a plan away.

## A Parliamentary Minute

#### Chapter Presidents:

Congratulations as you come to the end of your biennium! A job well done! You are now in the position to mentor your incoming Chapter President or perhaps you are staying in the position for another biennium. Hopefully the following suggestions will guide you in mentoring the incoming President.

• Do plan an Executive Board meeting before the end of June. This is a transition meeting and hopefully all outgoing members as well as incoming members will be invited to attend.

• Please guide your new President as she fills committee chairs and committee members. Let her take the lead but often you have valuable insights.

- Often incoming Chapter Presidents have told me that they don't know about programs for the Two-Year Directory which is due on July 1, 2024. Perhaps as an Executive Board this can be done as a joint venture. Use your Chapter EEC (Program) Chair to guide you in this endeavor. Sometimes the Vice-President fills this role in a chapter.
- This is the time when the new President and her Executive Board will either reappoint the Chapter Treasurer or ask someone else to take this position. This is an Executive Board decision and should be voted on.
- IMPORTANT: If you have a new treasurer, the motion needs to state her name and include that her name will be on your chapter bank account and the former treasurer's name needs to be

removed from the accounts and needs to be noted in the motion.

- The incoming President needs to appoint the Chapter Parliamentarian.
- REMINDER: LDS for incoming Chapter Presidents is going to occur during the Spring Seminar/Executive Board meeting in Utica on April 19-20, 2024. This will take place on Saturday, April 20 th. Session 1 is 10:45-11:15 and session 2- 11:30-12:15.


#### Alpha Nu Project- Domestic Shelter Pocketbook/ Literacy Program
